PLEASE NOTE THE FOLLOWING CHANGES:

CC 04-2223 NONPUBLIC SCHOOL EVALUATION & DETERMINATION SERVICES

1. Consent of Surety: Change Page 13 Item #7 to read:

Each respondent shall submit with its proposal a certificate from a surety company stating that the surety company will provide the contractor with a performance bond in an amount up to 20% of the total contract not to exceed \$500,000. (N.J.S.A. 18A:18A-25). Such surety company must be licensed and qualified to do business in the State of New Jersey. The certificate (consent) of Surety, together with a power of attorney, must be submitted with the proposal.

Failure to sign the Certificate (Consent) of Surety by either the Surety or Principal, and/or failure to submit the properly executed Certificate (Consent) of Surety with the proposal, shall be deemed cause for disqualification and rejection of the proposal.

2. Change Page 22 Item #26 paragraph one to read:

The successful vendor shall furnish a Performance, Payment and Completion Bond in a sum of at least twenty percent (20%) of the total amount payable by the terms of this Contract. Such bond shall be in the form required by Statute.

3. Change Page 49 Insurance Requirements A

- a. Insurance requirements will mirror the requirements set forth in the Technical Specifications on **Pages 18-20**. A **\$4,000,000** Excess Umbrella Liability Insurance Policy is required.
- b. **Automobile Insurance** is required only if applicable i.e. if needed for the delivery of Services by the Provider. If the Provider travels between schools or drives to a students' home to provide services then Automobile Insurance is required in the amounts specified on **Pages 18-20**.

4. Change Page 68 Item L Compensation

The Board shall pay the Contractor for the actual Services provided at the per pupil payment rates established for the **2022-2023** school year by the State of New Jersey Department of Education for each case, less an amount equal to **one percent (1.0%)** representing an administrative fee which shall be retained by the District. Contractor shall only be entitled to be paid for Services actually rendered consistent with the Federal and State rules, regulations and authorized regulatory guidance applicable to the provision of the Services.

The Board agrees to pay the Agency the FY 2022-2023 Nonpublic Per Pupil Rates, *less one percent (1.0%)*, which will be retained by the Board to implement administrative services, pursuant to N.J.S.A. 18A:46A-8.

5. Amend Item d on page 64 of the E&D RFP to read as follows:

The notice requirement page, to include a narrative with current placement, program, and related services, must be completed prior to obtaining parent consent at the meeting. If the parents are in person, they must sign the notice requirement page. If not in person, a copy of the email sent to the parent or a copy of the certified mail receipt should be included.

In addition, all appropriate documentation shall exist as to the attempts to have parent/s attend the meeting/s, and, should they not attend, appropriate documentation that notice was provided as to any and all determinations effectuated.
