Each cost category was evaluated separately based on 50 points. The score for each price category was then averaged with all of the categories per vendor. This score plus the technical and management scores determined the final score per vendor based on a 100 point system.

Catapult lost .5 points as they did not completely delineate how Title IV activities would be conducted. They lost 1 point for not fully describing how PD activities shall support safe and healthy students as delineated in the RFP.

Tree of Knowledge lost 5 points for not providing documentation for the minimum of four (4) employees holding an active NJ Teaching Certificate

Tender Touch received a perfect score in the Technical and Management criteria.

M2 received a perfect score in the Technical, Management and Cost criteria and scored 100 points overall. The original report indicated M2 proposed \$600 for MA/MS or higher. This was corrected to the proposed amount of \$650 indicated on their proposal sheet. As a result all scores changed slightly. This did not affect the awards.

All four vendors were responsive and responsibility to the technical specifications of CC 03-2223 and each scored above the minimum 75 points required for award.

The Evaluation Committee recommends award of contracts to all 4 vendors. Contracts are based on Nonpublic school vendor selection process and availability of grant funds.
