All respondents were responsible and responsive to the specifications of this competitive contract.

NOTES:

Catapult listed a different hourly rate for Title I BA teacher in the body of their proposal but this was not requested on the proposal page. The District only requested one hourly rate in this category and therefor the rate listed by Catapult on the proposal page of the specifications was the cost used throughout their response. Catapult did not delineate clearly what criteria they would be following and

lost 1 point. They also lost .5 point for not showing evidence of using standardized test scores for determining eligibility in two separate instances. Catapult's proposal was missing one certification of their staff and lost 1 point and also lost 2 points for not providing evidence of an effective record keeping system. They lost a point for failing to list the allowable services to be provided under Title I. Under Title III they lost a total of 3 points for not provided the requisite number of ESL certifications. Lastly, Catapult lost 2 points in their explanation of Title IV presentations.

Tender Touch received perfect scores for both Technical and Management in all categories.

Tree of Knowledge lost 5 points for failing to affix a copy of NJDOE approvals for these services with their submission. They lost 1 point for omitting a portion of the requisite items under the counseling category and 5 points for failing to show evidence that services will be in compliance with eligibility criteria for Title III. They lost 3 points for not providing all supporting background documentation for their paraprofessionals.

All three vendors are recommended for award by the Evaluation Committee.
