Mr. Luick – "There will be a presentation this evening by Dr. Weintraub dealing with our art program."

Dr. Weintraub thanked the Board for inviting him and stated that not only is the Fine Arts Department following the requirements set by the core curriculum content of the State of New Jersey, they are exceeding them. "For the last eight years the district's curriculum for the Fine Arts Department has been aligned with the content standards. All of our students grades K through 6 no matter what their disability are guaranteed one full period of music and art a week. All of our students in grade 7 and 8 get music and art one day per week and the high school all of our students take by law one year of art. When I did my homework, I discovered that one out of every three students in Lakewood High School take music, art or theater more than one time. Some take it up to four times. I think that's because we have some outstanding faculty. Thanks to the Board of Education and grant funding, Mr. Luick has permitted the entire Fine Arts Department to go to Lincoln Center on the first day of school for a workshop on aesthetic education where all of teachers learn how to use language arts, writing, reading in the teaching of language arts. Mr. Phillips, Vocal Music teacher in Clifton Ave. was on national public radio prior to Christmas with a major concert choir. Also he was part of a chorus to be on a commercial for the pre-game show at the Super Bowl. Mrs. Landesberg was invited to a symposium at four museums in New York City. She studied different works of art and how to incorporate them into the classroom. Mr. Wittemann, instrument teacher at the Middle School was given a lifetime achievement award from the New Jersey Chapter of the International Association of Jazz Educators and Miss Laura Cheney, an art teacher from Clifton Avenue, has been featured in School Arts Magazine, but she is an executive on the Art Education of New Jersey team to present at the Annual Conference of Art Educators and is going to

02/28/07 Pres. Cont. be one of six teachers in the state who hold national teacher certification for the teaching of art and that's just a few of the teachers in this department. With the guidance of teachers like this, our students have won Teen Arts Contests, Tournament of Bands Contests. Music in the Parks Contest. Mr. Picone here at Lakewood High School at Channel 77 and he is continuing to expand his viewership by adding many programs. Again, I want to thank the Board for the support of the Fine Arts Program and just to remind you that in this era of no child left untested, we have been working and planning our lessons to meet music and artistic skill so that every child can be full. In a few minutes Mrs. Landesberg will be speaking to you about some of the art presented in the Teen Arts Show. I also want to invite you and I will be sending a personal letter in a few days to come and see the annual musical this year. We are doing "Sugar, Some Like it Hot". If you remember the movie with Tony Curtis and Jack Lemmon, we are doing it right here at Lakewood High School. Performances will be March 23, 24 and 25. Full orchestra and full set, choreography, dancing. Just tell me how many tickets you would like and I'll be glad to send just as many as you need."

Mr. Galdo – "I have two questions, are we putting out a little more publicity to the community to come and see our musical programs whether they be in the high school or in the elementary schools or middle school? Now that we have our TV channel, seven days a week, have you given any thought to advertising what we do?"

So as parents come to see the children's art, they will also hear from social services, parent resource, etc. I really am hoping to get a big crowd in."

I've attended a couple performances and I've seen some of the different art work, and I'm going to come at you with a little more complex question and mine is one of who is sort of guiding some of these kids to put together portfolios. And are we getting any kids who are getting offers for art and fine arts to go on to some of those other prestigious colleges and universities?"

Mrs. Landesberg – "A couple of things. I've been teaching more than twenty years and I still love what I'm doing and to answer a couple of questions, my advanced students all have portfolios. Some of them do become art majors. We have a student now at FIT. We have students at the School of Visual Arts in New York. I encourage them, if they are going to major in art to go to either New York or Philadelphia. You know, they should be in a big city and a couple of the parents are pretty restrictive. They're afraid to let their kids go away. I have some boys so talented and the parents don't want them to leave Lakewood. It's a shame. This year unfortunately we are unable to attend Teen Arts but we are exhibiting anyway because Teen Arts is being held at Ocean County College during our spring break, but I will have approximately 40 students' works there. This collection here this evening is just a few of the pieces going into the show. The kids really pick their own works. I try to encourage them to select what would exhibit better or be featured better, but it's really up to them. And some of these are assignments that they have done. Some are self portraits. There's one here called the "three faces of me" conceived by the student.

Mr. Galdo – "I didn't know that we had an art colony right in our high school and so many talented people running it. And again I thank you because I believe that if you allow children to take their talent and do what they've done with it under supervision, we don't have the disciplinary problems that we could."
