then determination is made and the individual is awarded the scholarship. It could be the Guidance Department and/or the individual. It depends upon how the scholarship fund was set up. I know in the Tom Hampton Memorial Fund, his wife is extremely involved with Guidance in determining who receives that scholarship."

Mrs. Miccio – "Another question puzzles me. It is the petty cash accounts on page 4. It says not exceed \$50. So I don't quite understand that."

Mr. Luick – "\$50 is the maximum amount that they can spend and Mr. Resnick can correct me if I'm wrong for any one particular item. Is that correct?"
