That is truly unbelievable and unacceptable and in past I would ask for a censure but was told that we are not the ones to censure the state. However

Mrs. Cucuro stressed the importance of preparing the teachers and parents in ways to help the children achieve.

Based upon what you say there and based on our professional development seminars that we have during the course of the year, do you think this year will become aggressively more in what you're doing with workshops and seminars and how we've developed in the two school systems, the K through 6 and the middle and the high school. Is anything going to change?"

Mrs. Cucuro – "I feel it. I have to tell you since January I've tried to visit as many classes as I possibly could and I'm talking from K through the high school to the alternative programs. We have, and I mean it sincerely. You have teachers there that want to learn. They are like sponges. So we need to give it to them. But it's the type of thing where we need to develop a relationship. They need to know that we are in the forefront with them. They need to know that we are in classrooms. I think we have a cadre of supervisors and people that we've brought it that come with great resources at the table. And I was just talking to the language arts supervisors today and we talked about sitting and developing a plan and what we will do monthly. The other thing is I believe is don't tell me, show me, I need to see it. And because as Mr. Andersen is making us be data driven, data says see it like it is. We have to be accountable. We have to make teachers accountable and we have to make students accountable as well for their learning as well. But I think with everything that we have in place, I think professional development will look differently. It will be more intense and all I could say is that based on the teachers that I've met, if we provide that to them, I can see growth in our schools."

is really very good and I think that most of it is doable. The only problem that is not your fault or anybody else's is getting the parents involved. Last year Mrs. Medina will tell you, the teachers put on a program with a carnival just to get the parents out. The children were taken care of and there was absolutely nothing. And they are trying because we know that if the parents, I know myself. If I don't get involved with my children's education, it's difficult. They like that, don't bother, but it's difficult. And yet we are unable to get the parents out."

Mrs. Cucuro – "I agree, I know it's hard. But yet I think you can't give up. You have to keep on trying because you never know. Once you reach out to one parent and they have a good feeling, then they talk to others and hopefully with time we will be able to get parents to come in. But it still doesn't take away from our responsibility with children. I'm a working parent so I understand what the stress is like not to be able to give for your kids, but it's still the responsibility of the educators to still expose the children to as much as we can. We cannot use parents as an excuse. That's my personal opinion. But at the same token we try to do the best that we can exposing children to as much as they need based on what they are not getting in the community or from their homes. And then we just keep on trying. We can't give up."

sitting there as volunteers. A very thankless position. You try your best and you succeed most of the time and your efforts are recognized and appreciated. The reason I'm here is because of the problem with Title I. You inherited the problem, it's not your fault. The problem is at least ten years old, at least. Maybe longer. You made a major departure from the past. I recognize it. Sometimes we were on opposite sides of the table from each other, but we were always on the same side of the children. So your efforts are being recognized and I'm here to say openly and publicly everyone that is sitting up there. The professionals, board members, everyone has been very, very helpful. At this point I would just like to support what I understand that Mr. Luick has made a recommendation of K-8. We would like to support that. As you know my name is Meir Hertz and I run a school downstairs. I have a little familiarity of the process. There is only one issue that really still needs to be resolved. One only. We have solved most of the problems. The one issue is and I want to give it to you straight. Very simply, the children in the non public schools deserve a full time office fully staffed with fully qualified people. A full time office locally staffed with full time people and if you could do that, that would be the last major improvement. We're sitting here in the museum. Not ironically. You're going to have a heritage, you're going to leave a legacy. I believe that this Board and these professionals will be remembered as the ones that turned the Lakewood NCLB program around. That's going to be your

legacy. The challenge is in your hands and it's up to you. You need a full time, fully staffed, fully qualified, Title I NCLB office. I will not beleaguer the point any longer. You have \$270,000 to do that. You have plenty of resources to do that even if you use only half of that."
